With this document, the company CANTONI & C. SPA., with registered office in Viale Abruzzi 72 - 20131 Milan (MI), owner of the website www.cantoni.it, intends to provide information regarding the methods of management of the website, in relation to the processing and protection of the personal data of the users who navigate on it, with direct access from the home page or from internal pages.

This document is a policy statement in accordance with the national regulations and the European Privacy Regulation No. 679/2016

1. Data controller

The Data Controller is the company CANTONI & C. SPA, with registered office in Viale Abruzzi 72 - 20131 Milan (MI). For any communication, the Data Controller provides the e-mail address cantoni@cantoni.it

2. Data Processors:

Your personal data will be processed not only by the Data Controller and the Data Manager, but also by the subjects in charge of the data treatment, i.e. the employees of **Cantoni & C SpA**, by its collaborators, consultants and professionals, within the purposes set out in point 6 and subject to the designation of the Data Trustees by the Data Controller/ Manager, including specific instructions necessary for the fulfillment of the regulations on the protection of personal data with particular reference to security aspects.

3. Place of data processing:

Data processing related to the web services of this site takes place at the registered office of the Data Controller in Via Roma, 9 20010 Boffalora Sopra Ticino and is carried out only by technical staff members of the Office entrusted with the processing, or by any person in charge of occasional maintenance operations.

4. Data Disclosure:

No data from the web service is disclosed or spread.

5. Purpose of processing:

The personal data provided by users who forward requests to receive informative material (newsletters, brochures, Cd-roms, answers to questions, promotional material in general and other technical documents) are used for the sole purpose of performing the service requested and are communicated to third parties only if this is necessary for that purpose (e.g., shipping services).

6. Types of data processed:

a) Navigation data - The computer systems and software procedures used to operate this website acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols. This information is not collected to be associated with identified interested parties, but by its very nature could, through processing and association with data held by third parties, allow users to be identified. This category of data includes the IP addresses or domain names of the computers used by users connecting to the site, the URI (Uniform Resource Identifier) notation addresses of the resources requested, the time of the request, the method used in submitting the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given by the server (successful, error, etc.) and other parameters relating to the user's operating system and computing environment. These data are used for the sole purpose of obtaining anonymous statistical information on the use of the site and to check its correct functioning and are deleted immediately after processing. The data could be used to ascertain responsibility in case of hypothetical computer crimes against the site: except for this eventuality, at present the data on web contacts do not persist for more than seven days.

b) Data provided voluntarily by the user - The optional, explicit and voluntary sending of electronic mails to the addresses indicated on this site involves the subsequent acquisition of the sender's address, necessary to respond to requests, as well as any other personal data included in the missive.

c) Cookies - Session cookies are generally essential to be able to distinguish between logged in users, and are useful to prevent a requested feature from being provided to the wrong user, as well as for security purposes aimed at preventing cyber attacks on the site. Session cookies contain no personal data and last for the current session only, i.e. until the browser is closed. The site uses the following Technical Cookies:

8. Method of processing:

Personal data are processed by automated tools for the time strictly necessary to achieve the purposes for which they were collected. Specific security measures are observed to prevent data loss, illicit or incorrect use and unauthorized access.

9. Communication and disclosure

The data collected will not be disclosed, sold or exchanged with third parties without the express consent of the interested party, except for possible communications to authorized third parties - committed to confidentiality or in the case they are appointed as data processors ex art. 29 of Legislative Decree no. 196/2003 - (such as IT support companies and hosting companies) when necessary for the purposes referred to in this statement. The data may be communicated to the competent authorities, according to the terms of the law.

10. Rights of data subjects:

The subjects to whom the personal data refer have the right at any time to exercise their rights towards the Data Controller as well as towards the Managers designated by the latter, in compliance with art. 7 of Legislative Decree 196/2003, which we reproduce, below, in full:

Art. 7, Legislative Decree No. 196/2003 of 30/6/2003 (Right of access to personal data and other rights)

1. The interested party has the right to obtain confirmation of the existence of personal data concerning him/her, even if not yet recorded, and to obtain their communication in intelligible form.
2. The interested party has the right to obtain indication of: a) the origin of personal data; b) the purposes and methods of processing; c) the logic applied in case of processing carried out with the aid of electronic instruments; d) the identification details of the owner, the managers and the representative appointed under Article 5, paragraph 2; e) the subjects or categories of subjects to whom the personal data may be communicated or who may become aware of them as appointed representative in the national territory, managers or agents.
3. The interested party has the right to obtain: a) the updating, amendment or, when interested, the integration of the data; b) the cancellation, transformation into anonymous form or blocking of data processed in violation of the law, including those that do not require necessity in relation to the purposes for which the data were collected or subsequently processed; c) certification that the operations referred to in letters a) and b) have been brought to the attention, also in terms of their content, of those to whom the data were communicated or released, except where this proves impossible or involves a clearly disproportionate use of resources compared to the protected right.
4. The interested party has the right to object, in whole or in part: a) on legitimate grounds, to the processing of personal data concerning him/her, even if pertinent to the purpose of collection; b) to the processing of personal data concerning him/her for the purpose of sending advertising or direct sales material or for carrying out market research or commercial communication.
